1 On October 1, 2007, this Court confirmed the May 7, 2007 award of the  
2 American Arbitration Association Arbitrator in this matter (the "Arbitration Award"),  
3 against NXIVM CORPORATION DBA EXECUTIVE SUCCESS PROGRAMS,  
4 which was attached to the Petition to Confirm Arbitration Award. In its Order, the  
5 Court directed that judgment be entered in conformity with the arbitration award.

6 Therefore,

7 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

- 8 1. Judgment is hereby entered in favor of Petitioner SITRICK AND  
9 COMPANY INC. as against Respondents NXIVM CORPORATION DBA  
10 EXECUTIVE SUCCESS PROGRAMS; and
- 11 2. Petitioner SITRICK AND COMPANY INC. shall recover from  
12 Respondent NXIVM CORPORATION DBA EXECUTIVE SUCCESS PROGRAMS,  
13 the principal sum of \$146,863.54, together with interest pursuant to California Code  
14 of Civil Procedure § 685.010 from the date of the Arbitration Award until paid  
15 forthwith, plus reimbursement of \$4,600, together with interest pursuant to California  
16 Code of Civil Procedure § 685.010 from the date of this judgment until paid  
17 forthwith.
